## Skin Elements Limited (SKN) - Launches New Skin Medical Range

Skin Elements Limited (ASX:SKN) (the Company) has, in its half year report announcement released to the market on 2 March 2020, confirmed its development program involving its Invisi-Shield skin medical range, and is now pleased to advise further details on Invisi-Shield.

As part of its ongoing research and development into natural skincare formulas, Skin Elements has been collaborating with Absolut Solutions Pty Ltd over the past two years on research and development and test marketing in the hand sanitiser products sector.

Skin Elements is now proceeding to bring the project to commercialisation as a range of personal care hand sanitisers under the Invisi-Shield brand.

Skin Elements has adopted best practice as set out in the Code of Best Practice for Reporting by Life Science Companies (Biotech Code) in reporting these developments and provides the following information on 4.1 Research and development and 4.3 Regulatory matters.

Invisi-Shield is a personal care sanitiser product range that offers personal users broad spectrum antimicrobial control and protection. The Invisi Shield Hand Sanitisers are deemed personal cosmetic products which comply with the Therapeutic Goods (Excluded Goods) Determination 2018. Invisi-Shield products are currently not required to be registered by the Therapeutics Goods Administration.

Skin Elements has commenced manufacture of its Invisi Shield natural hand sanitiser plant based alcohol (70% sugar cane ethanol) formula with natural moisturisers (aloe vera, vitamin E and glycerine) at contract manufacturer AWARE Environmental Ltd for 60,000 units in March and 200,000 units in April, under normal commercial terms and conditions. These products will be available from March online through the Company's website and through select Australian distributors.

Skin Elements is also in the final formulation stage of two Invisi-Shield alcohol-free hand sanitiser proprietary formulas. Once the formulas have been finalized, the assessment of the appropriate regulatory framework and applicable independent laboratory testing program will be undertaken. Further information will be provided at this time prior to launch.

Mr Peter Malone Executive Chairman says" the unprecedented demand for hand sanitisers has seen the Company respond with decision to proceed to a launch of the Invisi-Shield hand sanitizer range. First production will see a hand sanitiser become available in March.
