SKN raising up to \$1.5 million

Australian natural skin care company Skin Elements Limited (ASX: SKN) (the 'Company') is pleased to advise that it is raising up to \$1.5 million in working capital through a combination of placement and entitlement issue to fund its stated business plans including the commercialisation of its all-natural plant-based SE Formula anti-microbial technology.

PLACEMENT

The Company has agreed to issue 28,000,000 ordinary fully paid shares at \$0.025 each (under the Company's ASX LR7.1A placement capacity) with one attaching option exercisable at \$0.05 on or before 31 October 2025 for each new share (under the Company's ASX LR7.1 capacity) raising \$700,000 in cash (before costs) in a private placement to sophisticated investors.

The placement Lead Manager is EverBlu Capital Pty Ltd, who will receive 6% fee of total funds raised as well as 2,000,000 ordinary fully paid shares and 28,000,000 options (exercisable at \$0.05 on or before 31 October 2025).

An Appendix 3B in relation to the placement and the shares and options to be issued to the Lead Manager follows.

ENTITLEMENT ISSUE

The Company is also pleased to announce that on completion of the placement it intends to proceed with a non-renounceable pro rata entitlement issue as announced previously, with the terms adjusted to match the terms of the placement. The revised entitlement issue will proceed on the basis of one (1) new share for every fifteen (15) ordinary shares held on the record date at an issue price of \$0.025 for each new share with one attaching option (exercisable at \$0.05 on or before 31 October 2025) for each new share issued.

Under the entitlement issue up to 31,075,660 shares and 31,075,660 attaching options will be issued raising up to \$776,891 (before costs).

The proposed entitlement issue is not underwritten.
