Breach of Listing Rules 10.11 and 14.7

Skin Elements Limited (ASX: SKN) ('Skin Elements', 'SKN', the 'Company') advises the following in relation to 55,293 SKN shares ('Giglia Shares') and 55,293 SKNOA options ('Giglia Options') issued to Colosseum Securities Pty Ltd pursuant to shareholder approval at the 2019 Annual General Meeting ('AGM'):

- SKN obtained shareholder approval for the issue of the Giglia Shares and Giglia Options on 29 November 2019. However, SKN did not issue the Giglia Shares and Giglia Options within one month after the date of the AGM (i.e., by 29 December 2019).
- The Giglia Shares and Giglia Options were issued to Colosseum Securities Pty Ltd on 15 January 2020. Colosseum Securities Pty Ltd is a related party of SKN as it is controlled by a director of SKN, Mr Phil Giglia.

SKN has breached Listing Rules 10.11 and 14.7 by issuing the Giglia Shares and Giglia Options more than one month after the date of the AGM.

SKN notes that the Listing Rules do not provide for the ratification of securities issued in breach of the Listing Rules.

In light of the above, SKN will procure Colosseum Securities Pty Ltd to dispose of the Giglia Shares on-market as soon as reasonably possible and by no later than 5:30pm (WST) on Wednesday 13 January 2021, with any profits donated to an entity registered with the Australian Charities and Not-for-profits Commission as a charity.
