ECO-Nurture Commercialisation Update

- Skin Elements in advanced-stage commercialisation negotiations for its ECO-Nurture sustainable, horticultural plant infection control technology
- Extensive evaluation and testing program of ECO-Nurture on kiwifruit orchards in New Zealand completed – shows ECO-Nurture can successfully eliminate harmful bacteria that affect kiwifruit plants without the use of chemicals typically used in agricultural settings
- Skin Elements is finalising negotiations for an exclusive distribution agreement with a leading rural co-operative to market, sell, supply and distribute ECO-Nurture
- Subject to execution of a definitive agreement, Skin Elements will receive an immediate \$600,000 payment on shipment of an initial 4,000 litres of ECO-Nurture for sale and distribution.
- Skin Elements also propose to enter into further negotiations for ongoing exclusivity on the sale and distribution of ECO-Nurture in New Zealand moving forward
- The commercial scale application of ECO-Nurture has potential to offer a viable, effective solution to a major crop protection and revenue loss problem in the kiwifruit industry

Skin Elements Limited (ASX: SKN) (Skin Elements, the Company), a world leader in the development of Australian all natural antimicrobial biotechnology, is pleased to provide the following update on its advanced-stage commercialisation plans for its ECO-Nurture sustainable, horticultural plant infection control technology.

Skin Elements has completed extensive evaluation of its ECO-Nurture's plant infection control product in kiwifruit orchards in New Zealand over the past 36 months, incorporating the 2023, 2024 and 2025 kiwifruit growing seasons.

The outcomes of this testing program has shown that ECO-Nurture has been proven to successfully eliminate all bacterial types that affect kiwifruit vines in the orchards, without the use of chemicals typically used in agricultural settings.

With its testing and evaluation program complete, Skin Elements is now in advanced stages of commercialising ECO-Nurture.

This represents a significant milestone for the Company and offers strong validation of the application of its plant-based SE Formula antimicrobial biotechnology platform to deliver viable commercial-scale alternatives to widely-used chemical-based products across the skin and health care, hygiene and agriculture sectors.

Skin Elements is currently finalising negotiations in respect of an exclusive distribution agreement with a leading New Zealand rural co-operative, to market, sell, supply and distribute ECO-Nurture.

Subject to the execution of a definitive agreement (which the Skin Elements has negotiated), Skin Elements will receive an immediate payment of \$600,000 on the shipment of an initial 4,000 litres of ECO-Nurture for sale and distribution across New Zealand.

Skin Elements is presently pursuing New Zealand government approval under the Agricultural Compounds and Veterinary Medicines Act 1997 (NZ) (ACVM) for ECO-Nurture. Once ACVM approval has been granted, Skin Elements propose to enter into further negotiations for ongoing exclusivity on the sale and distribution of ECO-Nurture in New Zealand.

Skin Elements Executive Chairman Dr Peter Malone said;

“Skin Elements is excited to commercialise ECO-Nurture as it continues to create and drive value for its shareholders. On successful execution, this will be the first commercial-scale agreement for our SE Formula antimicrobial biotechnology formula, which underpins all our products.

ECO-Nurture has undergone extensive testing on kiwifruit crops in New Zealand in a variety of settings, from initial small-scale testing, to larger hot-houses and orchards. Its ability to kill bacteria that is particularly harmful and damaging to kiwifruit, while not adversely impacting the health of the kiwifruit plant, as can occur with widely-used chemical-based sprays, provides a major potential breakthrough in kiwifruit crop protection technology, and offers a viable and effective solution to a major crop protection and revenue loss problem in the kiwifruit industry.”

This announcement has been approved by Executive Chairman, Peter Malone.
